**Title of the Best practice:** From Cleanliness to Prosperity

**Goal:** The aim of conducting this activity is to spread awareness among the people regarding the cleanliness, its importance and its need. Through this activity it is focused that the problem of uncleanliness that is spread in the communities of Gadchiroli city to be solved and to create awareness regarding this problem among the people of community and to request the Municipal Corporation to take initiatives to work directly in the community for maintaining the cleanliness and providing facilities to the people so that the people should use these facilities for maintaining cleanliness and keeping climate healthy.

1. To guide the people for the advantage of cleanliness.
2. To acquaint the people with the disadvantages of uncleanliness.
3. To engage the Municipal Corporation in this activity so that their contribution will solve the issue of uncleanliness.
4. Municipal Corporation should provide equipment to the people to dispose of the garbage and to maintain cleanliness.
5. To contribute to maintain healthy environment.

**Context:**

During the survey conducted by the students of BSW part-II, sem-IV, it is observed that several wards of Gadchiroli City are affected largely with uncleanliness. It is observed that this kind of condition is hazardous for the health of the people. Therefore, it is decided to motivate the people for cleanliness and take the support of Municipal Corporation in maintaining the cleanliness.

**The Practice:**

The students of BSW part-II have conducted the rally first for the awareness of cleanliness and performed the street plays on the importance of cleanliness topic. The people are acquainted with the importance of cleanliness. Through the rally and the street plays the people are also made aware with the duties of Municipal Corporation regarding keeping the environment clean and maintaining the cleanliness in the wards. To dispose of the garbage and to provide the facility of “Garbage vehicle” in the wards regularly. The people of the wards are guided to write application to the Municipal Corporation regarding to provide these facilities to the community and pay attention to the problem of uncleanliness.

The Chief Officer of Municipal Corporation has issued the order to provide “Ghanta Gadi” (“Garbage Vehicle”), other facilities. As per the direction and order of the Chief Officer of Municipal Corporation the waste was disposed of and the drainage were cleaned. The people came forward and took oath to keep the wards clean and to dispose of the waste properly.

**Evidence of Success:**

- The Chief Officer of Municipal Corporation issued the letter to clean the wards.
- The Chief Officer provided the “Ghanta Gadi” for carrying waste and ordered to clean the drainage.
- Many people participated in cleaning the areas.
- The flow of the water from drainage became smooth.
- The Chief Officer appreciated the task of the students.
